We still have over 25 members that need to return completed 2020 Enrollment Forms. You can call Tiffany in Eligibility at 1-800-258-8923.

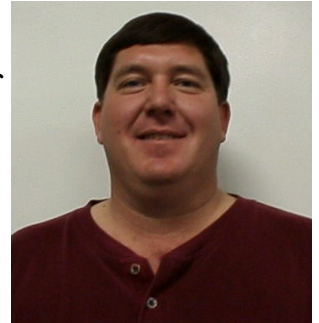
