<u>401k Fund:</u>

If you wish to make changes to or start your 401(k), please submit your forms by March 15th to be effective April 1st. If you need a form for changing your hourly deduction or investment choice, contact the Hall or email Kelly at **kelly@local101.net**. You may also print the forms from the Local 101 website and mail or fax them to us.

PENSION:

If you are retiring, follow these steps:

Notify the Pension Fund a minimum of <u>three months</u> before your retirement date, which is always the 1st of the month. So, if you want to retire 12/1/2025, let us know by September 1, 2025.

You will be mailed an application, once you receive, complete, and return the application.

Then, you will get mailed your Election Forms from Ekon Benefits, this is where you select what monthly option/ amount you want to receive, these forms get returned to the Pension Fund so you can start receiving your direct deposit/check on the first of the month.

You can request an Estimate prior to retiring, just call Kelly in the Benefit Office at Local 101 and she will have Ekon Benefits mail you your ESTIMATED Election forms, which show you all options and amounts available for your retirement.
